#### **GENERAL INFORMATION AND PURPOSE**

The Procurement and Contracts Branch (PCB) of the Hawaii Department of Education (HIDOE) competitively solicited qualified providers to work with HIDOE Schools and Offices to engage, collaborate and coordinate school/complex/complex area-specific 21<sup>st</sup> Century Community Learning Centers (CCLC) program services to improve student achievement and social development.

The primary purpose of this Vendor List is to engage Contracted Providers in implementing practices that are evidence based. These supports, programs, and assistance are customized to meet the specific and unique needs of each school. Services are designed and delivered to identify improvement areas and develop and implement successful strategies that build school sustainability and reflect student achievement. The services are an integral part of out-of-school time learning, and support students — particularly students who attend schools in need of improvement — with academic enrichment opportunities and support services to help them meet state and local standards in core content areas. 21st CCLC programs provide students with opportunities for academic enrichment, youth development and family engagement.

This Vendor List brings Contracted Providers together with HIDOE schools and offices to create a 21<sup>st</sup> CCLC program developed through a collaborative effort between at least one HIDOE school or office and at least one Contracted Provider. The participants will form a partnership which will coordinate the services and develop and implement the program.

## **USE OF VENDOR LIST OPTIONAL**

Schools are not required to purchase from the Contracted Providers, and waivers (Request for Exception Form 5) from this Vendor List are not required. Schools may determine purchases from this Vendor List are not suited to the School's purpose and may purchase these services from other sources, however, the usual procurement rules and procedures apply to such purchases.

## **VENDOR LIST PROCEDURES**

- 1. Request for Collaboration: HIDOE school, complex area, complex, or office implementing 21CCLC programs will select and contact a Contracted Provider from this vendor list.
- 2. Acknowledgement: Contracted Provider will acknowledge contact by the HIDOE school, complex area, complex, or office within 4 working days.
- 3. Submission of Proposal: In collaboration with the HIDOE school, complex area, complex, or office, the Contracted Provider will complete and submit a proposal detailing services aligned with Vendor's approved contract to the HIDOE school, complex area, complex, or office for review.
- Upon review and approval of proposal, Schools/offices complete contract process by using the <u>SPA Form Vendor List E18-09</u> (https://docs.google.com/spreadsheets/u/0/d/1WArGLXvtUKhRzMz-za7kqtFsaUfPqLz\_AXpLhHqlP0/copy?pli=1 <=google link).</li>
- 5. HIDOE school, complex area, complex, or office will notify CEB and provide a copy of the contract, payment schedule and purchase order.

Schools are not required to obtain the compliance documents (including a tax clearance certificate) when issuing final payment.
