

Palapala hō'ike makahiki no ka kū'ē ho'okae 'ili a me ke kū'ē ho'okano

E ho'okae 'ili ho'i ke Ke'ena Kula Aupuni o Hawai'i (Hawai'i State Department of Education) (HIDOE) e pili ana i ka lāhui. ke keka, ka makahiki, ka waiho'olu'u o ka 'ili, ke aupuni, ka ho'omana, a i 'ole ke 'ano kuku'e. E ho'ili pū ho'i kēia i nā polokalamu a me nā hana a pau i pili i ke Ke'ena HIDOE a pili pū ho'i i ka hai 'ana i kekahi limahana a me nā 'ae e pili ana i ia hana.

'A'ohe kulana 'ae komo no nā polokalamu HIDOE e ha'awi ai i nā polokalamu Kula 'oihana loa ma nā papa pāpaho (Career and Technical Education (CTE) Programs of Study), pāheona, ka'a'ike, pā'oihana, kōkua olakino maika'i, 'oihana loa wilikī, nā 'ike 'ikehu honua, kumuwaiwai 'āina a me nā kōkua no nā kānaka. E hō'oiā ana nā Kula Ki'eki'e o ke ke'ena HIDOE he nānā 'ole 'ia ho'i ke komo 'ana mai o nā haumāna me ka li'ili'i o nā 'ike 'ōlelo Pelekāne a me ke komo 'ana aku ma nā polokalamu CTE a e kōkua like ana ho'i i nā pono i loa'a no nā haumāna i pono e loa'a kēia mau kōkua nei.

I kekahi mea a'e, e ho'omanawanui 'ole ho'i ke ke'ena HIDOE i mea ho'okano e pili ana i ka lāhui, ke keka, ka makahiki, ka waiho'olu'u o ka 'ili, ke aupuni, ka ho'omana, a i 'ole ke 'ano kuku'e. E paipai 'ia nā haumāna i 'ike ua ho'okano 'ia lākou e kekahi e pili ana i kō lākou lāhui, ke keka, ka makahiki, ka waiho'olu'u o ka 'ili, ke aupuni, ka ho'omana, a i 'ole ke 'ano kuku'e e hō'ike aku i kēia mau hana i hana 'ia iā lākou. Hiki i nā haumāna a me nā mākua ke ho'opi'i aku i nēia mau imihana nei i ke Ke'ena Kāko'o Pono Sivila o ke Ke'ena HIDOE (HIDOE's Civil Rights Compliance Office) ma nā helu wahi i loa'a ma lalo iho nei.

'A'ole loa ho'i ke Ke'ena HIDOE a 'āpono i ka ho'oku'u wale 'ia kēia 'ano 'imihana 'ana me ka noi'i 'ole 'ia o ka hana hewa. Loa'a nā kāko'o e like me nā kōkua a'oa'o a me nā pono kāko'o kula, e loa'a no ho'i kēia mau kōkua nei i nā haumāna i ho'okano 'ia, a me nā haumāna i 'ike 'ia ua komo pū i loko o ka ho'okano 'ana aku i kekahi e pili ana i kō lākou lāhui, ke keka, ka makahiki, ka waiho'olu'u o ka 'ili, ke aupuni, ka ho'omana, a i 'ole ke 'ano kuku'e. Inā e 'ike 'ia ua 'imihana a i 'ole ua ho'okano kekahi haumāna i kekahi haumāna, e ho'opa'i 'i'o 'ia ana nō lākou a o ka ho'opa'i ho'i, ua hiki no ke ho'omaha lō'ihi 'ia a i 'ole hiki ke kipaku 'ia mai ke kula mai inā pili i nā kānawai ma ka palapala ho'opi'i. Pono nā haumāna, nā mākua, a me nā limahana HIDOE e hana like no ka pale 'ana aku i nā ho'okano 'ia 'o kekahi mamuli o kō lākou lāhui. ke keka, ka makahiki, ka waiho'olu'u o ka 'ili, ke aupuni, ka ho'omana, a i 'ole ke 'ano kuku'e.
