An email notification of the art award nominees and instructions for the submission of selected artwork will be sent by **Friday, February 22, 2019** to the nominees' teachers.

Awards Ceremony

An Awards Ceremony honoring student nominees and their teachers will be held on **Saturday, May 4, 2019** at HiSAM from 3:00pm to 5:00pm. Neighbor island nominees and their teachers will be provided air and ground transportation to attend the ceremony.
