# TEACHER EDUCATION COORDINATING COMMITTEE (TECC) Annual Report 2001-2002

The annual report of the Teacher Education Coordinating Committee (TECC) is submitted to the Hawaii State Legislature in compliance with the provisions of Section 304-20, Hawaii Revised Statutes.

TECC membership consists of representatives of Hawaii's major institutions of higher education (IHE), who participate in the preparation of teachers and other education professionals. TECC members include Brigham Young University-Hawaii, Chaminade University of Honolulu, University of Hawaii at Hilo, University of Hawaii at Manoa, and the University of Phoenix, Hawaii. The Hawaii State Department of Education is also a participating member of the TECC. The TECC met from October 2001 through May 2002 for a total of seven meetings.

The Superintendent of Schools, Department of Education, and the Dean of the College of Education, University of Hawaii at Manoa, shared leadership roles for the TECC. Superintendent Paul LeMahieu served as chair until October, while Superintendent Patricia Hamamoto served as the chair, facilitating meetings from November 2001 through May 2002.


The past year witnessed significant changes within the Department of Education (DOE). In addition to the change in superintendent, there was a shift from seven districts to fifteen complexes and a total reorganization of the state office. Along with these organizational changes, the department felt the impact of Felix Consent Decree Initiatives and the reauthorization of ESEA Title I No Child Left Behind Act (NCLB). Given that these changes had direct impacts on teacher preparation policies, TECC meetings addressed completion of prior-year tasks, transition of licensing functions from the Hawaii DOE to the Hawaii Teacher Standards Board (HTSB) and meeting new teacher preparation requirements.

#### I. Task Completion

#### ❖ Hawaii State Approval of Teacher Education

The committee completed its report on the department's newly adopted performance-based standards for the approval of Hawaii's teacher education programs. This process is based on the alignment of standards, evidence of effectiveness and program improvement driven by assessment.

- Standard I: Candidate skills, knowledge and dispositions
- Standard II: Assessment system for candidate performance and unit evaluation
- Standard III: Field experiences and clinical practice
- Standard IV: Diversity
- Standard V: Faculty, qualifications, performance and development
- Standard VI: Unit governance and resources



### Loan Forgiveness Program

HB1667, Act 307, which provided funds to students at UHM and UHH, was passed by the legislature. The Board of Regents adopted the administrative rules in Spring 2002 and began implementation in Fall 2002.

During the 2002 legislative session Senate Bill 2816, passed the legislature but vetoed by the Governor due to technicalities.

#### Fingerprinting

The revisions to Chapter 8-7 were completed and submitted to the Attorney General for review and input. The process of screening new employees will be streamlined with the purchase of scanners for each district office. Fingerprints will be sent directly to the FBI with a turn-around time of twenty-four hours. The background check will extend to all employees of the DOE inclusive of substitute teachers and teacher trainers.

#### Professional Development

The Professional Development and Educational Research Institute (PDERI) was established in January 2001. The focus of the institute is leadership development. Initiatives pursued by the unit focused on the (1) Beginning Teacher "Think Tank"; (2) Teacher Development; (3) Professional Development Schools; and (4) Mentor Support.

The guidelines and procedures for professional development credit were clarified, streamlined and made user friendly. Credits for reclassification must now be related to the school's improvement plan. In June 2002, the section (PDERI) is scheduled to disseminate all approved courses through the Internet with quarterly updates of all courses. The PDERI will continue to monitor and evaluate the content presented and the quality of the instructor.

#### II. Transition of Functions from DOE to Teacher Standards Board

- ❖ The TECC subcommittee met in January and February 2002 to identify and resolve issues relating to the implementation of Act 312. Discussion centered on identifying items necessary to meet the licensure requirements and the development of a process to provide a smooth transition of functions. Timelines were identified for the submission of records electronically or by hard copy. Roles and responsibilities of the IHE and the students were identified.
- ❖ The DOE will continue meeting with the HTSB to develop a plan for the transmission of personnel records. These meetings will continue throughout the 2002-2003 academic year to resolve unanticipated issues.
- ❖ The current criteria for out-of-state teacher education program approval are:
  - 1. The off-campus program is a state-approved teacher education program in its own state.
  - 2. The off-campus program is the same or comparable to the program delivered on its home campus.
  - 3. Transcripts of the off-campus teacher candidates completing the program shall bear the appropriate State Approved Teacher Education (SATE) statement.
  - 4. Access to library resources is assured to support off-campus programs.
  - 5. The system to monitor the off campus program in Hawaii is in place.
  - 6. The off-campus program shall provide a coordinator based in Hawaii for the placement and supervision of the candidates during the student teaching component.
  - 7. The degree program must conform to minimum standards and must incorporate the *Hawaii Teacher Performance and Licensure Standards* and the *Hawaii Content and Performance Standards*.
  - 8. The site or facility to be used for the classes is in compliance with Department of Education policies and regulations.
  - 9. The Board of Trustees of the Institution guarantees to the satisfaction of the Hawaii Department of Education that the operations in the State of Hawaii will be financially solvent.

### III. Teacher Preparation

- The shortage of teachers has been an on-going issue with the Department of Education. To address the shortage of teachers and other personnel, the Office of Human Resources developed a section whose primary function focused on immediate capacity and infrastructure development in the areas of personnel marketing, recruitment and retention. In addition, the TECC committee reviewed several initiatives to meet the needs of the department.
  - 1. The South Carolina Teacher Cadet Program is an introduction or orientation to the teaching profession. Its main purpose is to encourage students who possess a high level of academic achievement and the personality traits found in good teachers to consider teaching as a career. The curriculum includes simulations and other "hands on" activities designed to excite students about teaching. Students are exposed to teaching careers and the education system through class discussions, observation and participation in public school classrooms.
  - 2. Troops-to-Teachers Program provides military personnel with a viable avenue to select teaching as a second career. Mr. Allen Awaya, Hawaii liaison, indicated that a large number of the trainees complete their educational training through alternative certification or endorsement programs. He shared the report from Southwest Texas State University on the effectiveness of the Texas Troops to Teachers Program. Currently Texas leads the nation in the number of veterans who have become teachers. The study confirms that the large population of males who are brought into the teaching profession do well in the critical shortage areas such as math, science and special education and remain in their positions beyond the first challenging years.
  - 3. The Waianae Cadet Program provides summer training for incoming juniors and seniors interested in working with disabled students as teachers, related service providers or educational assistants. Students enter into a four week summer program consisting of classroom instruction and field experience. Placement occurs on the elementary school sites and cadet teachers are assigned to assist the teachers in the implementation of lessons. In addition, cadet teachers are provided visitations to various programs throughout the state and shadow a related service provider.

4. Incentives to attract students to the field of education include stipends, the loan forgiveness program, early placement of student teachers, and scholarships. The department will continue to review other alternatives such as greater availability of scholarships, educational loans, housing allowance, tax credit, etc.

The TECC membership wishes to acknowledge the continued support and commitment of the Hawaii State Legislature to ensure quality education for students enrolled in the public schools of Hawaii. The cooperative efforts of the TECC members and their respective institutions and organizations affirm a legacy of caring and excellence in education.

Minutes from May 15, 2001 meeting were approved as circulated.

## Information/Reports:

- Annual Report to Legislature: Linda Johnsrud shared draft report for review and feedback; final copy to be prepared for approval at 11/13 meeting.
- HTSB/NCTAF Updates: Sharon Mahoe reported that Hawai`i's NCTAF policy committee is now focusing upon developing a strategic action plan and reviewing the need for additional legislation and/or amendments to last year's bills. She stated that HTSB has been reviewing technical changes that are needed to the language in parts of Act 312 and does not foresee substantive changes to the bill. The broad parameters regarding the licensing renewal process are under review by the attorney general. Transitioning issues are being discussed with the DOE with concerns relating to the HTSB budget and procurement rules for contracting of vendors being resolved through the attorney general. Date for licensing functions to begin by HTSB is July 1, 2002; staffing funds will be available during the 4th quarter. If the development of the technology is delayed because of the budget and procurement regulations, HTSB's contingency plan is to process licenses manually. Regarding SATE concerns, she indicated that HTSB does not plan to change the standards.
- Lt. Governor Mazie Hirono affirmed the commitment of Hawai'i's NCTAF Policy Commission to continue to move forward this year with its professional agenda as "nothing is more foundational than our educational system."
- DOE Recruitment Needs & Teacher Employment Report: Amy Yamashita highlighted current efforts by the DOE to fill teaching vacancies, i.e., bringing back

retirees, recruitment fairs by Columbus and various districts, and major out-of-state recruitment trips this fall and spring. She responded to concerns expressed about the various tables and information presented in the *Teacher Recruitment Report 2000* and will follow through with the Teacher Recruitment Unit. In response to the request by the IHEs to see the "Big Picture" regarding where teacher shortages are with the DOE, especially in relation to projections relative to retirements and student enrollment data, a presentation was requested for the next TECC meeting.

## Discussion/Action/Questions:

RE: Student Loans for Teacher Education Students at Private IHEs: Sharon Har and Robert Witt commended the leadership of the Lt. Governor and cited her commitment to quality education for Hawai'i's children. A direct result of her NCTAF leadership was the passing during the recent legislative session of five major education bills.

Sharon Har and Robert Witt described their efforts "to continue the conversation initiated by the NCTAF Policy Group" regarding HB1667, Act 307. The Bill was recently passed and funds student loan forgiveness programs at UHM and UHH; the proposed legislation is to include teacher education candidates at the private IHEs. Because Article X, Section I of Hawai'i's Constitution limits recipients of state funds to state institutions, the issue is now in the attorney general's office. Sharon and Robert are in the process of developing an argument to present to the Governor to refute this position and make a policy decision to supercede the Constitution. Private IHEs are invited to forward to Robert Witt supporting position statements for the expansion of the loan forgiveness program to include private institutions.

- Dr. LeMahieu presented these items:
  - 1. NCTAF, as well as the DOE, have both urged that ways be explored to increase access to teaching, e.g., NDEA, Teacher Corps, by creating incentives to attract people into teaching. He expressed his willingness to lead a TECC initiated subcommittee to "craft legislation" in this regard. The following volunteered: Keiki Kawai ae a, Sharon Mahoe, Jan Zulich, Fay Ikei, Ray Winstead, Phyllis Unebasami, and representatives to be named from UHM, UOPH, and Chaminade.

- 2. Professional Development Schools Phyllis Unebasami was asked to describe the legislation for PDS schools. She indicated that PDS schools need to be identified by December 1, 2001 with the funds to be distributed in January. She will be taking applications from IHEs and schools.
- Michael Fassiotto, Chaminade University of Honolulu, asked about the teacher bonus only being for teachers who completed the UHM master of education degree program. He stated that this question came from a Chaminade graduate who had informed him that a letter had been received from Dr. LeMahieu with that information. Dr. LeMahieu indicated that he was not aware of such a letter.

### 4. DRAFT Copy of Chapter 7 of Title 8

She reported that the FBI is currently updating their fingerprinting scanner, which transmits information directly to the bureau. Fingerprinting and criminal check also extends to substitute teachers.

Roy Winstead questioned whether fingerprinting is restricted to teacher preparation programs or other areas (i.e. social workers). Does it extend to anyone who has contact with children?

Renee Tarumoto related that there is a need to review the intent of the law to address other areas outside of the IHE's (i.e. bus drivers, bus aides, etc.). The law must be changed to be more inclusive through changes in the statues.

- Transitioning of Functions to HTSB: Roy Winstead shared the subcommittee report of 02/07/02 identifying issues and making recommendations relating to the implementation of Act 312. Issues:
  - 1. The use of social security numbers to identify students (Family Educational Rights of Privacy Act)
  - 2. Accuracy and timing of eligible list

#### Recommendations:

- 1. Share the updated DOE Organizational Chart
- 2. Professional Certificate update and projected status in relation to ACT 312
- 3. Creation of Professional Disposition and SATE review Implementation subcommittee.

Licensing applications from California and Indiana were shared with the members. IHE's were reminded to bring sample applications for discussion at the next TECC meeting.

- HTSB Update: Sharon Mahoe reported on a bill in the legislature to change the name of HTSB and add the additional responsibility of licensing administrators.
  - She indicated the new standards would be discussed in March relating to the SATE review.
  - HTSB will be meeting with the DOE to discuss the issue of endorsement, which is not indicated, on a license. Possible solutions include (1) using DOE procedures, (2) recognize the endorsement on the license or (3) modify the endorsement procedure.
- Professional Development Credits: Tom Pangilinan indicated that he is the point person to process all PD credits. The state will continue to use the

June 1999 professional development guidelines. However, the Design Team will review the guidelines to make it user friendly and streamline the process. Teachers may continue to use PD credits for reclassification, however, 50% must be related to SID activities. In June 2002, the Professional Development and Educational Research Institute will disseminate a catalogue of all approved PD courses through the Internet. The Institute will provide quarterly update of courses, monitor and evaluate the content presented and the quality of the presenter.

Roy Winstead convened the meeting at 10:10 a.m. in the absence of Patricia Hamamoto who facilitated the meeting after the presentation of Mr. Allan Awaya.

Minutes from the February 12, 2002 meeting were approved as circulated.

## INFORMATION/REPORTS:

Troops to Teachers: Allan Awaya shared the partnership program with the Department of Education. The program is designed to recruit retired military personnel to become teachers in the public school. Allan requested information from the various colleges on their teacher preparation programs. He emphasized the need for alternative certification programs for the non-traditional student and shared the current program at Norfolk, Virginia. In addition, he requested that the colleges focus on the qualifications and experience of the retired military personnel. If possible have the training programs begin prior to separation from service. Clara Burrows indicated that the programs are on the Title II website.

As part of the partnership program, Renee Tarumoto stated that the Department would provide office space for the recruiter.

- DOE Recruitment Needs: Amy Yamashita discussed the recruitment needs of the Department of Education focusing on the following points:
  - 1. Student Enrollment over the past 10 years
  - 2. Increase in Teacher positions
  - 3. Acute shortage areas
  - 4. Supply of teachers
  - 5. Demographics of new hires and rehires
  - 6. Recruitment efforts and process
  - 7. Web page recruitment
  - 8. Incentives for hard to fill schools
  - 9. Contracted services
  - 10. Hiring priorities and applicant processing

Roy Winstead questioned if the DOE had a profile of the mainland recruits. Does the Department have a tracking system to indicate how long the mainland recruits remain in Hawaii? Secondly, is there information as to why teachers leave the system? He also inquired as to why the enrollment has dropped in our public school system.

HTSB Update: Clara Burrows reported that HTSB adopted the standards. She indicated that out of state programs must address Criterion 1, Additional Criteria for out-of-state teacher education program approval, before continuing on to address the remaining eight criteria. It is essential that the program be approved in its own state.

The board reviewed the new license application and a critical piece is the assessment form submitted by the college and the CT. The information normally submitted for licensure is the application, transcripts, PRAXIS scores, and evidence of student teaching. License will be granted upon completion of all paperwork.

HTSB will rework the DOE endorsement route for licensure. An updated report will be submitted at a later date.

 Licensure Forms: Roy Winstead requested that a standard statement regarding the use of social security numbers be used by all IHE's. The review of teacher application forms was tabled to the April 9th meeting.

Renee Tarumoto reported that she will follow-up on the criminal history check. Information will be shared at the 04/09/02 TECC meeting.

 Legislative Update: Patricia Hamamoto related that the cross over of bills occurred on 03/13/02. All the NCTAF bills went through, however, the retired administrators bill was held up.

Claudia Chun convened the meeting at 10:10 a.m. in the absence of Patricia Hamamoto. Estelle Wong, Director of the Student Services Branch, was introduced to the group.

#### **REPORTS:**

- Legislative Update: Claudia Chun reported that the School Administrator bill was not moving in the legislature however, all other bills were moving during the cross over.
- South Carolina Cadet Program: Linda Shimamoto representing Alpha Delta Kappa discussed the implementation of the South Carolina Cadet Program in three high schools during the 2003 school year through a partnership program with higher education. This would be a means to attract students to the field of education and address the current teacher shortage. - Legislative Update: Pat Hamamoto reported that the NCTAF bills passed along with the Loan Forgiveness Program. The School Administrator bill did not pass this session.
- DOE Issues and Concerns: Pat Hamamoto shared the following priority concerns for the department:

Grace Blodgett expressed the need to mentor teachers after graduation and establish partnership programs with the department.

- Computer Software for Teacher Tracking: Paul McKenny presented the computer program utilized by the university to track students. Fact sheet provided for Task Stream and Live Text.
- Teacher Records: Sharon Mahoe indicated that TSB wants to have a
  paperless system that empowers the teachers with the licensure and renewal
  system. TSB does not want to create more work for the users (DOE/IHE)
  and for the TSB Board.

Presentation by Michael Fluharty and Jamie Bellance on the software program. A training session for the DOE and IHE will be scheduled during the summer.
