

## Ka manawa ho‘ona‘auao kaulike kūpon

Ke ho‘olaha ‘ia nei kēia pepelu e ke Ke‘ena Kula Aupuni o Hawai‘i (HIDOE – Hawai‘i State Department of Education) i mea e hō‘oia aku ai i kō lākou kuleana a me ka hahai pū ‘ana aku i nā kānāwai ho‘okae‘ili o ke Aupuni o Hawai‘i a me ke Aupuni Pekelala. ‘O ke kumu o kēia palapala nei ‘o ia no ka ho‘omaopopo ‘ana i nā mākua/nā mākua mālama a me nā haumāna, he kapu ho‘i ka ho‘okae‘ili ‘ia ‘ana o kekahī haumāna ma muli ho‘i o ke ‘ano o ka lāhui, ke kala o ka ‘ili, ke aupuni i hānau iai, nā hulu kūpuna, kō lākou keka, ‘ano keka (inā he māhū a i ‘ole he wahine paha i no‘ono‘o he kāne ‘o ia) ka pae makahiki, ke ‘ano o ke kūku‘e a me kō lākou ho‘omana. Pili ho‘i kēia mau pāpā ‘ana i nā ‘ano polokalamu ho‘ona‘auao like ‘ole, nā papahana i ho‘oholo ‘ia e ke Ke‘ena i hō‘ike ‘ia maō ke kulekele o ka Papa Alaka‘i i ke Kula Aupuni (BOE - Board of Education) #305-10, pila i kapa ‘ia *Ka pila ho‘okano ‘ole, hana‘ino ‘ole, ho‘okae‘ili ‘ole i nā haumāna e nā limahana a pau*. Eia hou kekahī i pili i nā kulekele ma luna iho nei, e pāpā ‘ia ho‘i nā ‘ano like ‘ole o ka ho‘okano ‘ia ‘ana / a me ka hana‘ino ‘ia ‘ana ma muli ho‘i o ko lākou nohona ‘ilihune a me kō lākou kūlana hi‘ona a me kō lākou ‘ano.

Inā no‘ono‘o kekahī haumāna ua ho‘okano ‘ia, ua hana‘ino ‘ia, a ua ho‘okae‘ili ‘ia ho‘i maō nā māhele i ho‘opa‘a ‘ia ma luna iho nei a e paipai ‘ia ho‘i nā haumāna i ho‘okae‘ili e ho‘omaopō koke aku i ko lākou mau kumu a i ‘ole i ka Po‘okumu, ‘a i ‘ole e ho‘omaopopo aku i ke nā limahana o ka lālā HIDOE Ka Māhele ‘Apono Pono Kiwila(CRCB – Civil Rights Compliance Branch). Pono e loa‘a nā palapala e hō‘oia aku ai i kēai hana nei, a pēia pu ho‘i me ka inoa ‘o nā po‘e i ‘ike maka i ia hana a me nā helu kelepona a i ‘ole kekahī pono e hiki ai ke loa‘a hou ka mea i hana ‘ino ‘ia maō kēia ho‘ohalahala nei.

‘O kekahī mea hou a‘e, pāpā pū ‘ia ho‘i o ka ho‘okae‘ili ‘ia ‘ana ‘o kekahī haumāna ma muli o kō lākou kulana keka (kāne, wahine, māhū). E hahai ana ke ke‘ena HIDOE i nā lula HIDOE i ka manawa e ho‘omākaukau ‘ia ai e hō‘ike i kēia mau hana i hana ‘ia, ‘akā ‘a‘ole ho‘i e kaupalena ‘ia i ka, ho‘ohana ‘ana i nā inoa a me nā paniinoa kūpono, ka ho‘ohana ‘ana i nā hale mālama ‘ōpio, a me nā lula no nā lole kūpono. Mana‘o ho‘i ke ke‘ena HIDOE he pono ho‘i ka hō‘ike ana aku o nā haumāna i kō lākou ‘ano keka a me kō lākou ‘ana e mamake ‘ia e kapa ‘ia a e maopopo ho‘i, ‘o ke kula ho‘i kekahī o na wahi palekana a kako‘o pū ho‘i i nā haumāna e makemake e hō‘ike aku i kō lākou ‘ano iho. No nā haumāna ho‘i i makemake i kēia mau kāko‘o, a i ‘ole no nā haumāna me nā mana‘o kapu e mamake ‘ole ‘ia e laha, pēia pū ho‘i me ka noi ‘ana ho‘i i wā ka‘awale no lākou iho no ka ho‘ohana ‘ana i ka lua, a i ‘ole ka lumi kuapo lole, pono ana lākou e ho‘omaopopo i ka po‘okumu ma kō lākou kula. Ua hiki pū iā lākou ke kelepona i ka hui CRCB ma ka helu kelepona ‘o (808) 586-3322 e pili ana i nā noi kāko‘o a me nā pono e pili ana i nā mana‘o kapu e makemake ‘ia nei.
