

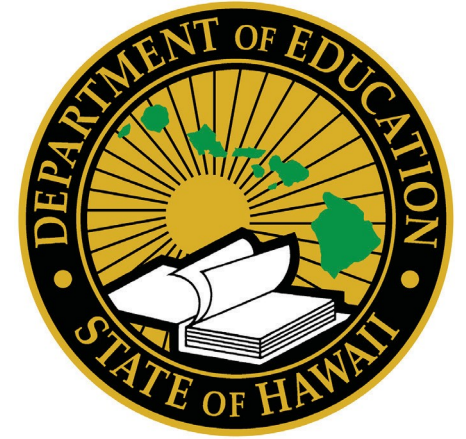

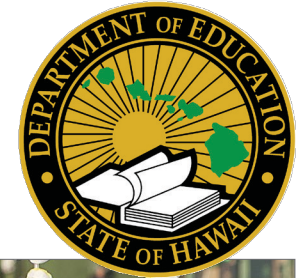

Kōjjeļā jeje eo ej kōmmejele aolepan menin kōjparok me rej pād ñan eok, ñan kapen ke eṃōj kowaļok ñan eok kōn aolepan maroñ ko aṃ mokta jān an Hawaii Raan Jeļāļokjeŋ eo (Ra) emaroñ in lale aṃ ak an nājūṃ benefit ko public ak joortoklik (āinwōt Medicaid/Med-QUEST) ñan kajjitōk kōn kōroḷ ṃōttan ñan menin aikuj ekkar ñan wūno/taktō im jeļāļokjeŋ, jipañ ko me rej ekkar ñan ājmuur im rej leļok ilo an nājūṃ Individualized Education Program (IEP, Būrookraaṃ in Jeļāļokjeŋ ñan Emake).

Elōn aṃ maroñ ñan bōk kōjjeļā ilo juon kajin me kwōj mejele. Ra eo ej aikuj in lewaj juon kōjjeļā jeje kōn maroñ ko aṃ kajjojo iō. Rej aikuj in jei kōjjeļā eo ilo juon kajin me public eo ej mejele im ilo lukkuun kajin jinen/jemen, ijellōkun ealikkar im ejjeļok iaļ ñan kōṃṃmane.

Kōm eban kowaļok an nājūṃ mejele ittino ñe kwōjañin kōmālim. Ilo aṃ leļok mālim juon-ien jān jinen/jemen, kwōj mejele ke Ra eo emaroñ in kowaļok mejele ko me ej kowaļok wōn eo nājūṃ me ej pād ilo an nājūṃ IEP (āinwōt etan ri-jikuuļ, atōrej, raan in ļotak, ri-jikuuļ ID nōṃba, handicap, raan in jipañ, im jipañ rot kar leļok). Barāinwōt, kwōj mejele ke Raan eo emaroñ in piil ñan an kien federal kōroḷ ṃōttan ikijjien menin aikuj ekkar ñan wūno/taktō im jeļāļokjeŋ, jipañ ekkar ñan ājmuur ilo IEP. Ra eo emaroñ in lale an nājūṃ benefit ko public ak joortoklik ñan kōļļā kōn jipañ āindein.

Elōn an nājūṃ maroñ ñan bōk Jeļāļokjeŋ Ejenolok im jipañ ko rekkaṃ im en ejjeļok wōṃean ñan eok. Ikijjien an Ra eo aikuj in leļok Juon Free Appropriate Education (FAPE, Jeļāļokjeŋ Ekkaṃ im Ejjeļok Wōṃean) ñan juon ajri ekkar iuṃwin IDEA, Ra eo ejaṃin kakien bwe eṃōj an ri-jikuuļ eo kaddeļoñ ilo Med-QUEST ñan bōk juon Jeļāļokjeŋ Public Ekkaṃ im Ejjeļok Wōṃean (FAPE).

Ñe elōn an jinen/jemen kōmālim, renaaj tiljek in dāpij maroñ kein me rej ļoor:

- Kwō ban bōk jabdewōt wōṃean itok-jān-bōjo, āinwōt kankan ak jīṃor-kōļļā;
- Ajāllikin aṃ kōmālim ejaṃin jabdewōt aṃ aikuj in kōļļā kōn jipañ ko me Med-QUEST enaaj kar kalbubuuk kōnke ajri eo nājūṃ enaaj bōlen bar aikuj jipañ ko likin raan in jikuuļ eo;
- Aṃ kōmālim ejaṃin kadikļok kalbubu in toan mour me ej pād ñan eok ak bar jabdewōt jipañ iuṃwin joortoklik;
- Aṃ kōmālim ejaṃin kōļapļok wōṃean joortoklik ak tōl ñan aer kaṃōj jipañ ko ak joortoklik; im



- Aṃ kōmālim ejaṃin kōṃṃan uwōta bwe en jako jabdewōt aṃ ekkar ñan kōjekdōḷon ko pedped ion ṃweo im jukjukin pād me rej pedped ioon tarlepin wōṃean men ko ikijjien ājmuur.

Kwō maroñ in bar bōk aṃ kōmālim an jinen/jemen ilo jabdewōt iien. Ñe eṃōj aṃ kōmālim āinwōt jinen/jemen ñan kowaļok mejele ko ittino ñan Med-QUEST, elōn aṃ maroñ me eṃōj kakien iuṃwin kien ko an FERPA ñan bar bōk mālim eo ilo jabdewōt iien eo im kwō kōṃaan.

Elañne kwōjjab kālōt ñan kōmālim ak kwōj bar bōk mālim, Ra eo ej aikuj wōt in lewaj jipañ ko kakien, im ejjeļok wōṃean ñan eok. Elañne kwōj kālōt ñan jab kōmālim ñan kowaļok mejele ko an nājūṃ me remaroñ in kile ñan Med-QUEST, ak ñe kwōj bar bōk aṃ kōmālim, ejjab jako eddoin Ra eo ñan kapen ke ej leļok ñan nājūṃ aolep jipañ ko kakien, im ejjeļok wōṃean ñan eok.

KŌMĀLIM JUON-IEN: Ra eo ej aikuj in leļok kōjjeļā jeje ñan jinen/jemen im bōk kōmālim juon-ien mokta jān aer lale Med-QUEST ilo iien eo kein kajuon. Ilo aṃ leļok mālim in jinen/jemen, jinen/jemen/ri-lale eo/ro ej kowaļok ke ej mejele maroñ ko an im ej rejetaṃ ke Ra eo emaroñ in lale Med-QUEST.

KŌJJEĻĀ ELECTRONIC: Kwōj aikuj in jei, jaini, im likūt raan eo ilo aṃ kōmālim. Kwōmaroñ in kōmālim ilo peba ak ilo wāween electronic. Ñe kwōj leļok mālim ilo electronic, aṃ submiti ej aikuj in kaṃool eok ke āinwōt armej ej kōmālim; kōpool juon jain im raan eo electronic; im kowaļok ke kwōj kōweeppān mejele ko me ej pād ilo kōmālim eo.

KŌJJEĻĀ KAJJOJO IŌ: Ālikin aṃ bōk kōmālim juon-ien eo, Ra eo ej aikuj in leļok kōjjeļā kajjojo iō ālikin ña jinen/jemen ri-jikuuļ ro me elōn aer handicap.
