2. Nupwen repwe finata pwe an noumw we semirit esapw tongeni angei aninis seni ewe prokram itan Free Appropriate Public Education (FAPE).

2. Ika ke tipeew ren ekkei annukun sukun, iwe, epwe namot pwe kopwe weweiti o pwan saini ekkei toropween tipeew me toropween tettenin parous tichik; **me**
3. Ika ke tipeew ren ekkei annukun sukun, iwe, kopwe tongeni siwini netipomw ika kese chiwen mochen mumuta ngeni och mettoch, ese pwan nefinifin.

Mumuta ren aewin mwichen interfiu

Non fansoun ika ewe Pwutai re nuku pwe noumw we semirit epwe tongeni angei aninisin sukunun handicap (usun met a fen mak non ewe Kinikin B seni IDEA), iwe ir repwe makkei echo toropween tingor ngonuk (*prior written notice*, wewen PWN), iwe, ekkei parous a men

mak non ewe kinikin *Tettenin Parous Mei Fen Mak Seni Me Noom me Toropween Tipeew Ren Sam me lin*.

Ika noumw we semirit a kan handicap, iwe, epwe auchea pwe ewe Pwutai epwe achocho ne cheki o pwan interfiu noumw we, pwe ewe Pwutai epwe tongeni fakkun sine ika mei tufich ren noumw we an epwe angei prokramen aninis, iwe, ika ewe Pwutai a men mochen fori e na interfiu, iwe, epwe tingor ngonuk ika mei tufich pwe epwe fori e na interfiu faniten noumw we.

Ika ka mumuta ren ewe mwichen interfiu faniten noumw we semirit, iwe, kopwe awora ngeni ewe Pwutai omw toropween mumuta; lwe, murin ewe interfiu, kopwe tongeni chok finata ika ke mochen noumw we semirit epwe fiti ekkewe prokramen aninisin handicap.

Omw we toropween mumuta epwe nonom faniten ewe prokramen aninisin sukunun handicap chok, usun met a fen mak non ewe Kinikin B seni IDEA (fan ewe Pwutai).

Fan ekkoch, non ewe fansoun emon iin ika sam ese mochen an noun we semirit epwe fiti ekkewe prokramen aninisin sukunun handicap, iwe, epwe namot pwe ewe Pwutai epwe tingor ngeni sam me iin ika ir repwe fiti ekkoch mwichen arongarong, pwe repwe poraus fongen usun ekkei tichikin IDEA.

Pwan ekkoch napanap faniten ekkewe semirit mei “foster”

Ward of the State, usun met a mak non ewe toropween IDEA me HAR 8-60, wewen nupwen emon semirit mei kan nonom fan Muun:

1. Usun emon semirit mei “foster”;
2. Usun emon semirit mei kan nonom fan pekkin ororen Muun; **ika**
3. Usun emon semirit mei kan nonom non och sakopaten shelter ika och sakopaten nenien tumun ren ewe ofesen *child welfare*.

Iwe, mei auchea pwe kopwe sine ekkei parous tichik. *Ward of the State* mei chok wewen ika emon semirit mei “foster” chok, esapw wewen ren emon semirit mei fen mwuuti, are ika emon semirit mei kan nonom non imwen iinan ika saman we (usun met a fen mak non ewe toropween IDEA me HAR 8-60).

Non fansoun an emon chon sukun mei nonom fan Muun (*ward of the State*) o esapw pwan nonom non imwen iinan ika saman kewe—

Mei chok mumuta ren ewe Pwutai an epwe fori ekkewe mwichen interfiu ika mwichen arongarong nupwen:

1. Nupwen ewe Pwutai mei chok kukutta ren iinan me saman kewe, nge esapw tongeni kuna ir;
2. Nupwen mumutan iin ika sam mei chok mwuch pokiten ororen Muun Hawaii; **ika**
3. Nupwen emon sowun kapwung epwe finata och mettoch faniten ekkei mwichen arongarong.

Mumutan sam me iin ren ekkei prokramen aninis

The Department must obtain your informed consent before providing special education and related services to your child for the first time. Non fansoun ewe poputan, ika ke mochen noumw we semirit mei handicap epwe tongeni angei och sakopaten aninisin sukunun

handicap, iwe, mi auchea pwe ewe Pwutai epwe tingor reom ika kopwe awora ngenir echo toropween mumuta.

Me mwen an noumw we semirit epwe poputa ne angei aninis, iwe, mei auchea ren ewe Pwutai epwe angei omw we toropween mumuta.

Non fansoun ika kosapw tipeew ren ekki napanap, ika kosapw saini ewe toropween mumuta, iwe, ewe Pwutai esapw tongeni aeni ekkewe napanapen tumun (usun “due process complaint”, mwichen umwuchen ekki napanap, mwichen arongarongen “due process” mei apeech, ika och sakopaten mwichen siwinin aninis). Iwe, ekkewe chon angangen IEP resapw pwan tongeni fori och mettoch ika kosapw mumuta.

Mei kawor ekkoch sakopaten parous mei auchea. Non fansoun ika kosapw tipeew ren noumw we semirit epwe angei aninisin sukunun handicap, me ika non fansoun kosapw pwan ponueni an Pwutai tingor reom ren omw we mumuta, me ika non fansoun ewe Pwutai mei chok atai an we pwon ngonuk usun ekki parousen aninis:

1. Ika kese mumuta ren ekkewe prokramen aninisin handicap, iwe, kopwe chiwen tongeni angei aninisin FAPE seni ewe Pwutai, faniten noumw we semirit; **me**
2. Ika kese mumuta ren ekkewe prokramen aninisin handicap, iwe, ewe Pwutai esapw tongeni awora mwichen IEP ika och sakopaten prokramen aninisin handicap.

Non fansoun ika kopwe finata pwe kese chiwen mochen noumw we semirit an epwe angei ekkewe prokramen aninisin handicap, iwe, kopwe tongeni makkei toropwe ngeni ewe Pwutai. Iwe, murin ika ka mwuchuno ekkewe prokram, ewe Pwutai esapw chiwen tongeni anisi noumw we semirit ren och sakopaten aninis. Iwe, ika noumw we semirit e kan touu seni ekkewe prokramen aninis, ewe Pwutai epwe ngonuk echo toropween esinesin faniten ekki foror (usun non ewe kinikin **Tettenin Parous Mei Fen Mak Seni Me Noom**).

Mumuta ren Mwichen Finata

Non fansoun ika ewe Pwutai mei mochen noumw we semirit epwe fiti och sakopaten mwichen arongarong (faniten och sakopaten foforen siwinin aninis), iwe, mei namot pwe ewe Pwutai epwe tingor reom ren omw mumuta. Fan ekkoch, ika ewe Pwutai ese tongeni angei an iin ika sam mumuta, iwe, mei chiwen tufich ren an emon semirit mei handicap epwe fiti ekkewe mwichen arongarong:

1. Ika non fansoun ewe Pwutai e kan fakkun achocho ne tingor ren an iin ika sam mumuta; **me**
2. Ika non fansoun iin me sam resapw ponueni an ewe Pwutai tingor.

Fan ekkoch, ewe Pwutai epwe finata pwe a men auchea an emon semirit mei handicap epwe angei aninis, nge iinan me saman kewe resapw fakkun mumuta ren. Iwe, ewe Pwutai epwe tongeni achocho ne awora aninis ngeni e na semirit mei handicap fan non ekki sakopaten fofor: “due process complaint”, mwichen umwuchen ekki napanap, mwichen arongarongen “due process” mei apeech, ika och sakopaten mwichen siwinin aninis (usun met mei fen mak non ewe Kinikin B seni IDEA).

Toropween Apwungu faniten ekki foforen tingor ren mumuta

Ese pwan nefinin, mei fakkun auchea ren ewe Pwutai epwe nukuw omw kewe toropween esinesin me toropween tipeew meinisin. Ewe Pwutai epwe mamasa omw toropween tichik meinisin. Iwe, iei tettenin parous tichik an ewe Pwutai epwe makketiw won toropwe:

1. Epwe makketiw parousen tefon meinisin, ika iteiten fansoun mei kawor kokor fongen;
2. Epwe nukuw echo kopian ekkewe toropwe meinisin en ke tinano ngeni ewe Pwutai pwan iteiten toropwe ewe Pwutai e kan tinano ngonuk; **me**
3. Epwe makketiw parous usun iteiten fansoun oupwe chufongen ren och sakopaten mwich, ika non fansoun an emon chon Pwutai epwe churuk non imwomw ika non nenien omw we angang.

Pwan Ekkoch Napanapen Mumuta

Iwe, mei fen mumuta ren ewe Pwutai an epwe fori ekkei fofor:

1. Ewe Pwutai mei tongeni aeni omw kewe tichik ka fen awora ngenir; **ika**
2. Non fansoun mei kawor och sakopaten testen sukun mei chok fis faniten chon sukun meinisin, iwe, epwe pwan mumuta ren an emon semirit mei handicap epwe pwan fiti e na testen sukun.

Non fansoun an emon iin ika sam epwe finata pwe an noun we semirit mei handicap epwe choni “private” sukun ika “homeschool” (sukun non imw), iwe, mei tufich ren an epwe angei aninis seni ewe Pwutai faniten noun we, nge mi auchea pwe iin me sam repwe ngeni ewe Pwutai ar mumuta. Ika iin me sam resapw mumuta, iwe, ewe Pwutai ese tongeni anisi ewe semirit mei handicap. Ewe Pwutai esapw pwan tongeni fori och sakopaten foforen aninis faniten ewe semirit, usun “due process complaint”, mwichen umwuchen ekkei arongarong, mwichen arongarongen “due process” mei apeech, ika och sakopaten mwichen aninis, ese pwan nefinifin.

Ekkoch napanap

Non fansoun ika kosapw tipeew ren an Pwutai finata, kopwe tongeni tingor pwe epwe kawor och mwichen arongarong itan *emon me emon mwichen arongarong faniten och sakopaten aninisin sukunun handicap (IEE)*.

Ika ke tingor ren e na mwichen IEE, iwe, ewe Pwutai epwe urenuk ika ie kopwe feino ie ren omw kopwe fiti ewe IEE. Epwe pwan urenuk usun och sakopaten parousen ewe IEE.

Wewen

An emon me emon mwichen arongarong faniten och sakopaten aninisin sukunun handicap (IEE) wewen ika mei kawor och sakopaten mwichen arongarong mei kan fis seni emon chon angang esapw angang fan ewe Pwutai nge mei chok angang ren pwan ew sakkun prokramen aninis.

Moni an muun, wewen nupwen ika ewe Pwutai epwe pwise moni ren ekkewe mwichen arongarong me prokramen aninis faniten chon handicap, usun chok met a fen mak non ewe Kinikin B seni IDEA. Nge ekkewe state meinisin non Merika repwe aeni ar moni an muun pwe repwe awora prokramen aninis faniten aramas re Merika, pwan kich meinisin sia kan nonom Merika.

Mumuta ren moni an muun

Non fansoun ika en kosapw tipeew ren och foforen me finatan Pwutai faniten noumw we semirit, iwe, en mei tongeni tingor ren e na IEE, iwe, ewe Muun epwe moni ren. lei napanapen moni an muun:

1. Nupwen en mei mochen ewe Muun epwe kan moni ren IEE, iwe, mei namot pwe kewe chon Pwutai epwe fori ekkei fofor: (a) Ewe Pwutai repwe tingor ren “due process complaint” pwe repwe achocho ne pwarata ngeni Muun usun ar finata faniten noumw we semirit, pwan repwe tongeni pwarata ngenir ewe popun ami ousapw tipeew fongen; ika (b) ekkewe chon Pwutai repwe chok mumuta ngeni ewe IEE ika mei tufich.
2. Non fansoun ika ewe Muun esapw mumuta ren ewe IEE, iwe, kopwe chiwen tongeni fiti e na mwichen IEE ika kopwe pwisen moni ren.
3. Ika ke tingor ren mwichen IEE, epwe namot pwe ekkewe chon Pwutai repwe kapas eis ngonuk ika pwata kosapw tipeew ngeni ar finata faniten noumw we semirit. Non fansoun ika mei kawor an Pwutai “due process complaint” ika och sakopaten mwichen arongarong, iwe, ewe Pwutai epwe chok achocho pwe ekkewe mwichen arongarong repwe fiis mwitir chok.

Kopwe tongeni angei moni an muun ren ew mwichen IEE, ina chok.

Pwan ekkoch mwich mei mumuta

Iwe, Mei kawor och sakopaten parous mei auchea faniten mwichen IEE (ese pwan nefinifin ika mei free ika esapw free):

1. Mei fakkun auchea ren ekkewe chon angangen Pwutai pwe repwe apeech faniten noumw we semirit, pwe ar finata meinisin repwe fat me pung. Ika epwe wor namotan mwichen IEE, iwe, ewe Pwutai epwe achocho ne fori mettoch meinisin mei each ren noumw we semirit (pwan usun FAPE); me
2. En me ekkewe chon angangen Pwutai oupwe tongeni fiti ewe mwichen arongarongen “due process hearing” faniten noumw we semirit.

Mwichen arongarong nupwen mei kawor emon sowunapen arongarong

Non fansoun an emon sowunapen arongarong epwe tingor ren IEE, iwe, ewe mwichen IEE epwe free seni moni an muun.

Napanapen Pwutai

Nge non fansoun an emon epwe kamo, unumi ika aeni och sakopaten safei mei afeiengaw, iwe, epwe atai annukun muun Merika. Non ewe toropween annuk, HAR 8-19, a men mak usun wewen “safei mei

afeiengaw”, pwan non ewe toropween annuk 329, Hawaii Revised Statutes pwan Kinikin 712, masowan IV, Hawaii Revised Statutes.
