Ahn directory information pwukoah iei mweidada HIDOE en kihiong information sang nan an serihn sukuhl records en Education nan wasa kan me pan sansalohng sukuhl o.

Ire kapatapat, federal law riau anahne HIDOE, me ale sawas pahn Elementary oh Secondary Education Act of 1965, me kamanamanlahr (ESEA), en kihda pwihn en pali en sounpei, sang ni ruwes, me iangahki information pwukat-ahd, wasahn kousoan oh nempahn delepwohn ohng serihn sukuhl en secondary kan-ihte ma peneinei men de serihn sukuhl eligible kan sohte kaweidki HIDOE me re sohte mwahuki information wet en kohda ma sohte kisin likou en kamweimwei ntingda.
