

## Distribution of Federal Coronavirus Aid, Relief, and Economic Security Act (CARES) Funds within the State of Hawaii

**Purpose of CARES:** The Federal government enacted CARES on March 27, 2020 to address necessary expenditures incurred due to the public health emergency posed by COVID-19 that were not accounted for in the most recently approved state budget, and incurred between 3/1/20 - 12/30/20.

**DOE Impacts:**

1. Personal protective equipment (PPE) provided through the Department of Defense.
2. Public-private partnerships to provide support to public high school seniors who were adversely affected by school closures in their final semester of school.
